



Terms and Conditions: PERFORM 2026

1. Promoter: AGCO International GmbH, Victor von Bruns-Strasse 17, CH - 8212 Neuhausen, Switzerland. AGCO Parts is a worldwide brand of AGCO Corporation.
2. Promotion: Customers in the UK are entitled to a 10% discount on any filters available on the AGCO eCommerce platform. The discount is represented by a specific percentage reduction from the listed price on the eCommerce platform for qualifying products.
3. Promotion Period: This promotional offer is valid from 1st May 2026 until 31st August 2026, subject to product availability. AGCO reserves the right to communicate the conclusion or termination of this promotion at any time.
4. Limitation: “**Customers**” are retail only – limited to end users who buy parts or services for their own farming operations. Customers can redeem this promotion up to a maximum of three (3) times per user during the promotional period, using the coupon code ["**FLT26**"]. The discount is calculated as 10% of the value of filter products purchased only, up to a maximum filter value of GBP 900 per purchase (or local currency equivalent, as determined by AGCO). There is no minimum order value required to qualify for the discount.
5. Redemption: This promotion is exclusively available for redemption on the AGCO Parts Shop platform in the UK (<https://parts.agcocorp.com/gb/en>). Customers must apply the coupon code ["**FLT26**"] during the checkout process in the designated discount code box. Upon successful application, customers will see the coupon code displayed as "applied," and the corresponding discount will be deducted from the subtotal of filter products.
6. Dealer Responsibility: Dealers are responsible for ensuring that the discount provided through this promotion is accurately reflected in the final customer invoice. The discount amount must be passed on to customers for the filter products, as indicated on the eCommerce platform.
7. The maximum total number of redemptions across all participating markets during the promotional period is limited to 3000 discount redemptions.
